Key Duties:	<ul style="list-style-type: none"> • Prepare consulting rooms ready for use. • To provide the efficient service of the day-to-day running of the clinic's, ensuring notes and x - rays are available • Carry out duties such as recording ECG, urinalysis, measuring weight and height, working out the BMI, taking base line observations including Blood Pressure, Pulse and Oxygen saturation, swabs, dressings, chaperoning as required • To complete wound checks at Crawley ensuring adhering to clinical competence, asepsis and escalating any surgical concerns appropriately • Work within the larger multi-disciplinary team at the Crawley MSK clinics • Assist at Crowborough (Horder) should patient demand require this. • To become involved in the construction, implementation and evaluation of the patient integrated care pathways. • Receive and action enquiries from patients and colleagues both face to face and via the telephone. • As necessary using the Patient Administration System at Crawley This will include checking of patient details, handling and checking of paperwork such as booking form, health questionnaire and consent Arranging diagnostics where necessary. Logging of patient case notes and completion of outcome forms. • Ensure all patient information is available, up to date and accurate. • Ensure outpatients are effective and efficient with smooth running of clinics, with a high emphasis on the provision of a good customer service and effective patient flow. • Receive patients/visitors into the area. • Liaise with MSK admin team and clinical staff to ensure effective smooth running of clinics, ensuring that Consultant-specific requirements are carried out prior to and post consultations. • Referring patients onto the pre-assessment team at Crowborough (Horder) for surgery when required. • To be proficient in safer patient handling and constantly being aware of the importance of using the correct techniques when moving patients due to their restricted mobility. • To be aware of your responsibility in relation to infection control policy and procedures i.e. effective hand washing technique. • To attend all mandatory training sessions at The McIndoe Centre in East Grinstead or The Horder Centre in Crowborough. • To extend your role as required under supervision following training.
