	To ensure that waste sacks are replaced when half full and that the bins are cleaned daily.
	To aid in patient service wherever possible and provide general support for both the Catering production and service teams.

	To put away deliveries into the appropriate form of storage, completing any associated records.
	To wash-up all soiled crockery, cutlery, glassware, and equipment using the appropriate methods.
