<b>Key Duties:</b>	<p><b>JOB SUMMARY/PURPOSE</b></p> <ul style="list-style-type: none"> <li>• Autonomously undertake electronic triage of new referrals and run clinics to assess new referrals into the Intermediate MSK Service (AP Service) and u</li> <li>• Use advanced clinical reasoning skills to clinically diagnose and manage a complex group of patients who have not responded to conservative measures in clinics held within Horder Healthcare, Sussex MSK Partnership East or general practices within the contracted Primary Care Network(s) (PCNs) where appropriate to job role.</li> <li>• Request and interpret appropriate diagnostic investigations such as imaging and pathology.</li> <li>• Provide a patient centred collaborative approach to assessment, diagnosis and treatment planning including providing patient choice and shared decision making and working within an MDT to provide a range of evidence-based treatment options, in line with clinical pathways.</li> <li>• Participate in the development of their specialist area within the MSK Service participating in clinical audit within the service and maintaining and improving all aspects of clinical governance, evidence based practice and quality assurance in the service area.</li> <li>• Manage and treat a caseload of outpatient musculoskeletal physiotherapy patients.</li> </ul> <p><b>RESPONSIBILITIES /DUTIES</b></p> <ul style="list-style-type: none"> <li>• Ensure fulfilment of the pillars of advanced clinical practice (Leadership and Management, Education, Research and Clinical Practise) as described by the Chartered Society of Physiotherapy and Health Education England.</li> <li>• Work collaboratively with HH MSK service leads, HH MSK Clinical Quality and Operational Managers and through planning with said managers, support the clinical / operational managers of Sussex Musculoskeletal Partnership (East). and PCN colleagues.</li> </ul>

- Participate in their own audit and research in collaboration with the MSK Clinical Quality Manager and other colleagues.
- Provide clinical leadership and expertise for Primary Care colleagues in the assessment, diagnosis and treatment planning for patients with upper limb, lower limb or spinal conditions, dependant on area of expertise.
- Provide specialist support and advice to colleagues and other healthcare professionals within primary and secondary care.

## **Clinical Responsibility:**

To be responsible for managing a complex clinical caseload, ensuring governance and quality assurance standards are met. You will have a highly specialised knowledge of assessment, evaluation and treatment techniques and will:

- Provide education to patients/carers regarding compliance with treatment and advice to support shared decision making.
- Provide specialist advice for patients to help them with self management and acceptance of their chronic pain/reduced function, with an emphasis on an evidence-based bio-psycho-social model of care. Provide advice on physiotherapy management and social prescribing.
- Request appropriate investigations such as X-ray, MRI and blood tests, reviewing results and making critical judgements as necessary.
- Select appropriate and individual treatment pathways e.g. onwards referral to conservative Therapies, Consultant led clinics etc.
- Engage in effective, timely communication with GPs, and secondary care where necessary.
- Take responsibility for delivering a whole system patient-focused approach and seamless care across professional boundaries, ensuring the safety, effectiveness and efficiency of the service at all times.
- Demonstrate advanced knowledge, skills and experience in the field of musculoskeletal disorders.
- Maintain an independent caseload of MSK Physiotherapy patients, leading by example to demonstrate effective evidence-based physiotherapy management of complex and routine patients
- Promote and demonstrate best practice, in particular to integrate the most up to date research theory into practice using advanced clinical decision making skills.
- Maintain contemporaneous written patient records to Intermediate MSK Service standards of all clinical observations and interventions.
- Exercise the highest degree of professional autonomy, using and

analyzing complex facts and situations to implement a treatment/management strategy for the patient.

- Create and develop protocols of care and design patient care pathways with the aim of providing examples of best practice across the regions and/or nationally.

## **Communication:**

The post holder will:

- Sensitively explain the results of investigations and clinical diagnosis including the prognosis (of the musculoskeletal condition) and all treatment options incorporating Shared Decision Making as required.
- Be required to communicate complex clinical information both written and verbal, in an easily understood form, to patients, careers, all members of the multi-disciplinary team and primary care colleagues.
- Teach therapeutic exercises, through verbal explanation, visual demonstration or the physical guiding of the patients movements, to patients and their careers.
- Advise patients on self-management activities to either treat their condition or assist in coping with their condition.

## **Education and Professional Development**

The post holder will:

- Be expected to develop and maintain all musculoskeletal clinical skills necessary for this position, keeping up to date with current developments in evidence based practice including reading relevant literature, and attendance at in-service training and external courses as appropriate.
- Ensure on-going use of CPD portfolio in line with current registration requirements.
- To participate in delivering a comprehensive training programme within the MSK Service, internally to HH teams but also externally to primary care teams and across the local health economy.

## **Research, Service Development and Evaluation:**

In conjunction with HH's MSK Clinical Quality Manager / SMSKPE and Pathway Leads / contracted PCNs, (as appropriate) the post holder will:

- Design and evaluate multi-professional systems of audit that aspire to quality improvement in the context of local and national guidelines.
- Promote and demonstrate research based practice, initiating and participating in research projects, and encouraging and supporting staff actively involved in research.
- Be responsible for identifying gaps in the evidence base.
